Data Sync Roadmap

- **New Product Introduction (NPI)**
 - ◆ Limited version of production – Roll out along with initial loads/cleansing
- **Data cleansing**
 - ◆ Begins October 06
- **Cost & promo**
 - ◆ Spring 07
- **Scan based trading**
 - ◆ Fall 07
- **RFID**
 - ◆ Undetermined



Progress Made in 06

- **Enhanced the buyer work station**
- **Enhanced the supplier work station**
- **Enhanced our cleansing process**



AAFES Initial Load Process

- **Requesting initial load contain only those items currently approved by AAFES**
- **Initial load items will be compared to the items currently in RETEK**
- **Match found**
 - ◆ **Core attributes will auto overlay item information currently in the AAFES system**



AAFES Initial Load Process Cont'd

➤ No Match

- ◆ Report generated**
- ◆ Cleansing team works with buyer to reject unauthorized items and/or identify new items to be added**
- ◆ New item – forwarded to the supplier work station**



Core Attributes

- ◆ **MSRP**
- ◆ **Weight (unit, case, inner, pallet)**
- ◆ **Height (unit, case, inner, pallet)**
- ◆ **Depth (unit, case, inner, pallet)**
- ◆ **Width (unit, case, inner, pallet)**
- ◆ **Ti/Hi**



New Item Process

- **Subscribe at GLN and GPC level**
- **Items go to the PIM supplier work station**
- **Supplier inputs**
 - ◆ **AAFES specific cost for each & case level**
 - ◆ **Supplier number**
- **Supplier approves and item goes to PIM buyer work station**



New Item Process Cont'd

- **Buyer enters**
 - ◆ **Department/class/subclass**
 - ◆ **Approves and forwards to RMS**

- **MST team attaches location to each item in RMS**

- **Item becomes active**
