- b. Round trip ground transfers between the airport and hotel.
- c. Double occupancy hotel accommodations consisting of one (1) standard room with a maximum of two (2) persons per room for two (2) nights at hotel in Hawaii to be determined by Sponsor.
- d. Five Hundred Dollars (\$500.00) spending cash for the winner.

Actual retail value may vary and depends on location of winner's residency and dates of travel. Any difference between actual value and ARV will not be awarded.
