

OFFICIAL CONTEST RULES

P&G TOUGH MUDDER PHOTO CONTEST

TOTAL PRIZE POOL VALUE: \$2,000

Sponsored by Army and Air Force Exchange Service. Prize is awarded by P&G.

Contest entry period begins 0800 CST October 17, 2018 and ends 2359 CST November 15, 2018.

1. Who can enter: All authorized Exchange customers 18 years or older at the time of entry are eligible to enter, except employees of the Exchange (including military personnel assigned to the Exchange and Exchange retirees), its concessionaires, contractors or representatives providing in-store service or working in an Exchange facility, and the immediate family members of the above. How to Enter: During the entry period, to submit a valid entry, entrants must (a) take a photograph of their most challenging stain and include your first name and last name, city, state and entrant's local Exchange.
